

AGREEMENT OF COLLABORATION

RE:

THE IMPLEMENTATION OF CONSORTIUM, ACQUISITION OF RESEARCH GRANT, AND RESEARCH, DEVELOPMENT AS CONSORTIUM “ASEAN NETWORK FOR URBAN RESEARCH”

On this day, Wednesday, July 26, 2017 at Putri Duyung Cottage, Jakarta, Indonesia, we the undersigned below have agreed to make an Agreement of Collaboration in the IMPLEMENTATION OF CONSORTIUM, ACQUISITION OF RESEARCH GRANT AND RESEARCH, DEVELOPMENT AS CONSORTIUM with the name of “**ASEAN NETWORK FOR URBAN RESEARCH**” which shall be expounded in the following articles:

Article 1

BACKGROUND

The acceleration of the transfer of knowledge from research to application in society in addressing the local and global issues and challenges in the urban society requires interdisciplinary and multidisciplinary synergy and collaboration, which is impossible to resolve without collaboration, serves as the background for the formation of this Consortium.

Article 2

PURPOSE AND AIMS

The purpose and aims of the Consortium are: to strengthen the network of ASEAN researchers through collaboration, researcher mobilities, joint proposals, joint publications, joint seminars, and other scientific activities which are deemed important in assisting the advancement of understanding in the challenges and problems faced by the urban societies in ASEAN region, through commitment to the network, enhancing collaboration within the network, mutual scientific support, mutual respect, and mutual trust.

Article 3

SCOPE

The scope of this Agreement of Collaboration includes:

1. The utilization of resources owned by the members in the form of structure, infrastructure, human resources, and budgets obtained from the Consortium which are needed to implement activities which are their responsibility as members of the Consortium;
2. Other activities agreed upon by the members in supporting the success of implementation of **ASEAN NETWORK FOR URBAN RESEARCH** consortium such as conferences, workshops, proposal writing, students and researchers mobility, joint publications, etc.

Article 4

DIVISION OF TASKS AND RIGHTS

In accordance with Article 3 mentioned above, each member is assigned tasks as follows:

1. To coordinate the implementation of consortium activities, be it management or research and development technicalities.
2. To integrate the results of research and development to make them one system so that it can form and function as planned.
3. To coordinate the process of utilization or dissemination of the results of research and development undertaken by the Consortium

Article 5

DIVISION OF OBLIGATION AND RESPONSIBILITY

The members are responsible for developing the Consortium in different forms of activity which support the aims as embodied in Article 1 and consciously planning to actively participate in reporting their activities in the mailing list or in Humboldt Kolleg activities.

Article 6

FUNDING

Members of the Consortium take an effort to acquire different kinds of research grants (national and international) through joint proposals, research collaboration or other forms which are approved by the parties fostering the collaboration to achieve the aims embodied in Article 1.

Article 7

DURATION

This Agreement of Collaboration is valid for 5 (five) years as of the date it is signed and extendable on the approval of the members.

Article 8

AMENDMENT AND ADDENDUM

1. In the event there is some modification in the content of this Agreement of Collaboration as a result of modification in the agreement of the members, the modification shall be conducted by way of AMENDMENT which is an inseparable part of this Agreement of Collaboration.
2. Other matters which have not been regulated in this Agreement of Collaboration shall be further regulated and determined by the members in the form of an ADDENDUM which is an inseparable part of this Agreement of Collaboration.

Article 9

OTHER MATTERS

1. Any difference of opinion which occurs in the implementation of this Agreement of Collaboration shall be resolved cooperatively as best as it can by way of deliberation for agreement.
2. The implementation of this Agreement of Collaboration shall be evaluated at least once a year by the members.

Article 10

CONCLUSION

This Agreement of Collaboration is made in good faith from all members, witnessed by the Head of Asian Division of the Alexander von Humboldt Foundation, Germany, Dr. Klaus Manderla, each of which is sufficiently signed which has equal legitimacy and each party receives 1 (one) original copy to be implemented fully responsibly and is effective as of the date as embodied at the beginning of this Agreement of Collaboration.
